II. ACTIVITIES AND COMPETENCES OF THE FOUNDATION'S BODIES

1. Council of the Foundation

The Foundation is governed by the Council of the Auschwitz-Birkenau Foundation. The

2. Management Board of the Foundation

The Management Board of the Auschwitz-Birkenau Foundation is the body managing and representing the Foundation to external actors. Board members are: Piotr M.A. Cywiński, Ph.D. (President), Rafał Pióro (Vice-President), Łukasz Rozdeiczer-Kryszkowski (Vice-President), Jacek Kastelaniec (Member of the Board, Director General).

In 2014, the Management Board held 6 meetings (February, April, May, July, September, December). Its particular duties were to: prepare the action plans and financial plans for the Foundation, managing the Foundation's assets, determining the size of the Foundation's staff and the amount of funds spent on salaries of the employees, according to the approved financial plan, accepting donations, inheritances, bequests, subsidies and donations.

In managing the Foundation's current activities, the Management Board is supported by the Foundation Office, operating in premises rented on concessional terms from the Jewish Community of Warsaw.

In 2014, the Board's activities still focused on soliciting further financial declarations for the Perpetual Fund through, among others, developing relations with diplomatic missions of

foreign governments in Warsaw, as well as direct relations in selected countries. The activities

in the USA were continued.

In 2014, the Management Board also concentrated on passing further income on the Perpetual

Capital for the conservation of the Memorial Site. 2014 was the third year during which the

Foundation financed the conservation work in the area of the Auschwitz-Birkenau State

Museum (Resolution of the Management Board No. 1/2/2014 dated February 4, 2014 on

allocation of the profit earned on the Perpetual Capital in 2013 to statutory purposes, i.e.

conservation of the Memorial Site). The amount of PLN 2 092 548.50 was transferred to the

account of the Auschwitz-Birkenau State Museum. In 2014, the Museum spent PLN 3

105 168.80 using also the funds transferred in 2013. The remaining amounts may be used by

the Museum at any time as needed under the Global Conservation Plan.

The following projects were implemented using the funds donated to the Museum in 2014:

• Modernisation of the warehouse for textile objects from the collection of the

Auschwitz-Birkenau State Museum in Oświęcim - STAGE I. Project regarding

special wardrobes to store textile objects;

• Conservation surveys necessary to carry out further work in connection with the

implementation of the Global Conservation Plan and maintenance of the Auschwitz-

Birkenau Memorial Site – STAGES II, III;

Preservation and conservation of BI section along with all related facilities – STAGE

II:

• Preparatory works necessary to carry out further conservation and construction

activities in the area of the former Auschwitz II Birkenau;

• Regulation of water relations of the former Auschwitz II Birkenau – STAGE I;

• Conservation of wooden objects in the area of the former Auschwitz II Birkenau.

In 2014, the activity of the Foundation was conducted thanks to the profits on the investment

of the Perpetual Capital, part of which was used to finance operational costs according to the

statutes, as well as the funds donated by KPMG Audyt Sp. z o.o. and Deloitte Doradztwo Podatkowe Sp. z o.o. to administration activities.

In 2014, the Auschwitz-Birkenau Foundation employed five persons full time:

with full access to information, as well as to maintain full transparency of the Foundation's

III. SOLICITING DECLARATIONS OF FINANCIAL SUPPORT FOR THE PERPETUAL CAPITAL

1. Countries

The letter sent out in February 2009 by Polish Prime Minister Donald Tusk, informing the leaders of over forty countries about the key intentions of the Auschwitz-Birkenau Foundation, as well as the task to collect 120 million euro for the Perpetual Capital, was received very well among many governments and heads of states. The letter of Polish Prime Minister Donald Tusk was sent out again in 2014 to twelve leaders of European and non-European countries, and was also received very well.

All of the payments and payment declarations from 2014 and previous years amount to the total sum of ca. 113 million Euro, which provides an optimistic outlook on the plans of complex conservation of the former Nazi German concentration and extermination camp Auschwitz-Birkenau according to the intentions of the authorities of the Auschwitz-Birkenau State Museum and the will of the International Auschwitz Council. In 2015, other states are expected to join the project. The Auschwitz-Birkenau Foundation conducts intensive negotiations with Spain, Slovenia, Chile, and Morocco. Further, also negotiations with Belgium and the Netherlands are being held on an increase in their respective contributions to the Perpetual Capital of the Auschwitz-Birkenau Foundation. The Polish Ministry of Foreign Affairs took active part in the organisation of visits of Board Members and the Foundation's employees to the aforementioned countries. Polish diplomats participated in numerous meetings abroad and helped establish and maintain many relations with members of foreign governments. The support of the Israeli diplomacy has also been very significant for the Auschwitz-Birkenau Foundation.

2. Individual donors and "18 Pillars of Memory" project

According to the decision made in 2012, the Auschwitz-Birkenau Foundation extended its activities in the United States. In 2013, Friends of Auschwitz-Birkenau Foundation was established, an American organisation raising funds for the Foundation. Owing to that, in 2014 the Auschwitz-Birkenau Foundation and the Friends of Auschwitz-Birkenau Foundation were able to initiate the "18 Pillars of Memory" campaign. The aim of the campaign is to invite 18 philanthropists to the project – individuals and institutions. Each of them will become a symbolic "Pillar of Memory" by supporting the Auschwitz-Birkenau Foundation with an amount of EUR 1 million. By the end of 2014, the Auschwitz-Birkenau Foundation and the Friends of Auschwitz-Birkenau Foundation managed to win 7 private donors.

2014 was an exceptional year due to the preparations related to the 70th Anniversary of the

Liberation of the Auschwitz-Birkenau Concentration Camp. The "18 Pillars of Memory"

Project significantly contributed to the deepening of relations with the American Diaspora. As

a result of the project, private donors were acquired who supported the Foundation's

Perpetual Capital. Therefore, the "18 Pillars of Memory" campaign is considered to be

successful.

IV. EXTERNAL SUPPORT FOR THE STATUTORY ACTIVITIES

In 2014, the Foundation cooperated with law and accounting firms. Legal assistance is

provided free of charge by Weil, Gotshal & Manges law firm. Tax advice, accounting and HR

and payroll services are provided by Deloitte Doradztwo Podatkowe Sp. z o.o. Courtesy of the

Union of Jewish Religious Communities in Poland, the Foundation rents office space at the

premises of the Jewish Community of Warsaw on concessional terms. Once again the audit

was performed by an independent auditor, KPMG Audyt Sp. z o.o..

PR support is still provided by Edelman PR on pro bono basis.

The Friends of Auschwitz-Birkenau Foundation, whose goal is the same as that of the

Foundation, conducts and supports fund raising activities of the Auschwitz-Birkenau

Foundation in the United States.

V. PLANS FOR THE YEAR 2015

In 2015, the main emphasis will be put on soliciting individual donors, both in the USA and

Europe, under the "18 Pillars of Memory" Campaign. The Foundation will continue

negotiations with states which have not confirmed their participation in the project yet and			
which may decide to increase their contributions to the Perpetual Capital.
